

# RESOLUTION

## Appointing and Confirming Members to the Historic Landmark Commission

**WHEREAS**, the City of Ravenswood has enacted §2.16.040 et seq. of the Ravenswood Municipal Code, creating the Historic Landmark Commission (hereinafter "Commission"); and

**WHEREAS**, the Code requires that the Commission shall: (A) Be composed of 5 members appointed by the Mayor of the City to a term commencing on the first day of August in the following manner: (1) One member shall be a member of the Common Council, shall be appointed by said Mayor and shall serve a term of 1 year; (2) Two members shall be appointed by the Mayor from the city at large, their initial appointments being for a period of 2 years and all subsequent appointments being for a period of 1 year; (3) Two members shall be appointed by the Mayor from the city at large, their initial appointments being for a period of 1 year and all subsequent appointments being for a period of 1 year; and

**WHEREAS**, the Commission presently has vacancies due to the expiration of the terms; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Common Council of the City of Ravenswood, hereby appoints and confirms the following Mayoral nominations to the Historic Landmarks Commission, as follows:

Ethel Lemley (1-year term)	August 1, 2025
Rob Benson (1-year term)	August 1, 2025
Pastor Chris Skeens (2-year term)	August 1, 2025
Faith Walker (2-year term)	August 1, 2025
Recorder, Jared Bloxton (1-year term)	June 30, 2024

The foregoing Resolution was introduced and read at the regular meeting of the Common Council of the City of Ravenswood on **June 4th, 2024**. On that same day, **Councilwoman Slaven** moved for the adoption of said Resolution and authorization for the Honorable Joshua Miller, Mayor of the City of Ravenswood, to sign said Resolution. The motion was seconded by **Councilman Tucker**. After discussion, the Common Council of the City of Ravenswood adopted the foregoing Resolution and authorization with **ALL** voting for the Resolution and authorization and **NONE** against.


